**CARC** provides services for children involved in foster care and other interested parties involved with children's cases. This can include:

- ♦ Attorneys or Prosecutors
- ♦ Parents or Relatives
- ♦ Guardians *Ad Litem*
- ♦ Social Workers
- ♦ Foster or Pre-Adoptive Parents
- ♦ Foster Children

## GUARDIAN AD LITEM SUPPORT CENTER (GALSC)

Specialized services for Guardians *Ad Litem* are an important part of the CARC Project. GALSC offers resources and services for Guardians *Ad Litem* at no cost, such as technical assistance and training, research, sample pleadings and litigation support.

## FOSTER CARE HELPLINE (FCH)

The Foster Care Helpline (FCH) provides legal advice, representation and referral services to foster care children, their foster care families and those involved with the Child In Need of Care system.
