Free Legal Assistance in Kansas: How to Apply and Qualify

Getting Legal Assistance

Individuals seeking legal assistance must first apply. Our field offices can't answer any questions or give legal advice until they have an application on file.

Kansas Legal Services gives free or low cost civil legal advice and representation for persons whose incomes make them eligible. You will find out if you are eligible for legal assistance by talking with an Intake Specialist, whether you apply online or call our intake line.

Need Legal Assistance?

You must apply first. Contact an Intake Specialist using one of the methods below.

→ **Online Application:** Use the link below. Available Monday 8:00 a.m. through Thursday 4:30 p.m.

→ **Phone Intake:** Call **316-267-3975** (Monday through Friday from 8:00 a.m. to 4:30 p.m.).

Application Methods Details:

1. Online Application: Fill out our [Online Application](#).

→ Available 8 a.m. on Monday through 4:30 p.m. Thursday.

→ We will email or call you. Look for the caller ID: **316-267-3975**.

IMPORTANT DEADLINE: The online application is NOT available from 4:30 p.m. on Thursday through 8 a.m. Monday.

2. By Phone: Call our Intake Specialist at **316-267-3975**.

→ Available Monday through Friday from 8:00 a.m. to 4:30 p.m.
