

LETTER FROM THE EXECUTIVE DIRECTOR

Serving as the Executive Director of Kansas Legal Services (KLS) is both a profound responsibility and a daily reminder of the transformative power of access to justice. This opportunity is also one of the greatest privileges of my life. After practicing law for 41 years, raising four children with my wife Lori, and contributing to the pro bono space for most of my career, I had a general sense that my life experience was informed and enlightened.

I was wrong.

This position has significantly expanded my understanding in ways that go beyond what can be summarized here. Still, I'll do my best to try. The overall gestalt of what I've seen is that where civil lawyers go lacking, the void is often filled with actors and entities who will seize upon vulnerable moms, dads, teens, and toddlers and push until someone stands up and says "no more." In almost every case, those two words are never uttered. KLS is not there. No one is. Any semblance of equal justice disappears.

And yes, there is so much that is positive and groundbreaking about our successes in 2024, but I can't help but acknowledge that so much remains the same, and our challenges are daunting.

To stay in this discouraging space for a bit longer, one of the most shocking revelations I've discovered is one of the black holes of justice in Kansas is something called the "limited actions docket" – known in the profession as Chapter 61 cases. This is where family dreams go to die. Where dads and moms try to navigate the labyrinth of rules of procedure alone with the inevitable result that families see when the sheriff moves their possessions to the street, where medical debt goes to default judgment, and cases are fast-tracked, from start to finish, in less than a month. In the blink of a legal eye, Kansans see paychecks garnished and, as we have seen time and time again, often it's done wrongfully.

Unlike nearly all other cases, in eviction cases, tenants often have to go to court with no way to compel the landlord to produce any of the relevant documents at trial, such as inspection reports. Also, unlike most other in cases, tenants can't get hearing dates moved back if they can't make a hearing date or to prepare for trial. In debt collection cases, creditors routinely "serve" people by posting court documents on a door and mailing them a copy by regular first-class mail. Then they can get a default judgment even if the debtor doesn't live there anymore, or if they never lived there. Also, the judges overseeing these proceedings are often not even lawyers. They are what is described as non-law trained magistrate judges. In our state, over half the magistrates are not lawyers.

To be sure, many, probably most, Chapter 61 cases are meritorious and there is overall value to a rapidly moving process that allows rights and remedies to be adjudicated expeditiously. But the system is imperfect, some would say flawed. I would say flawed. I cannot count how many times I've uttered to myself, "How can this be?" KLS attorneys have been doing more in Chapter 61. When we get involved, the dynamics change on a dime.

I was student in this area of law because KLS has become more invested in this universe. We've been taking cases in this space and making a difference, particularly as it relates to medical debt collection cases. Our role will expand and it's my hope that in next year's report the tone will be markedly improved.

But yes, 2024 was our best year yet. We helped more than 23,000 Kansans with a wide range of legal issues. Our advocacy not only levels the playing field in court—it also puts money back into the hands of local families. Whether it's securing child support for single mothers or clearing criminal records so people can access better-paying jobs, the impact is tangible. In fact, last year an independent study found that our work generated a \$60 million positive economic impact across the state.

One client story is worth sharing here. We recently helped a mother in Riley County secure survivor benefits for her infant son after the child's father passed away. Because the father's name wasn't listed on the birth certificate, the Social Security Administration initially denied the claim. With our help, the claim was approved in January 2024. As a result, this toddler received a lump-sum back payment of \$2,959 and ongoing monthly benefits of \$432.

Stories like this demonstrate that our work is about more than legal procedure; it is about securing stability and dignity for families. While the systemic challenges are significant, the tangible impact we have on thousands of lives, like that young child, fuels our determination. As we look ahead, we are committed to expanding our presence in critical areas like the Chapter 61 docket and continuing to be a voice for those who would otherwise go unheard.

Thank you for your belief in our mission and your support in making access to justice a reality for more Kansans.

KLS OVERVIEW

VISION

Since 1977, KLS has progressively focused efforts on persons with special needs, domestic violence victims, crime victims, the homeless, children in foster care, consumers with debt disputes, the elderly, those with disabling conditions, individuals with barriers to jobs and housing, and those seeking mediation services.

MISSION

- Kansas Legal Services is legal aid in Kansas, providing equal access to justice for the most vulnerable Kansans.
- KLS provides legal services to alleviate low income Kansans' poverty burdens. KLS has eleven field offices and two mediation offices located across Kansas.

PROGRAMS

ELDER LAW

KLS coordinates with local Area Agencies on Aging and the Kansas Department for Aging and Disability Services as a legal service provider in the state aging network. Older Americans Act, county Mill Levy funds, and other private funds address this growing area of need. Senior Citizens Law Project (SCLP) provides services in a wide range of civil legal issues to persons age 60 and older. SCLP's objective is to target the more vulnerable elderly population who are in the greatest social and economic need.

KLS also operates the KLS Elder Rights Project which provides assistance for seniors who are victims of financial fraud, exploitation, domestic abuse and other crimes.

HOUSING LAW

KLS helps Kansans with many aspects of housing that tenants and homeowners face, including confronting discriminatory practices by landlords and lenders, and resolving unsafe rental housing conditions.

KLS also provides foreclosure prevention legal assistance through a grant from the Kansas Bar Foundation. Hundreds of Kansas families have been helped to prevent or resolve foreclosure actions.

FAMILY LAW

KLS represents thousands of low income persons each year in domestic matters through many funding sources, including: Access to Justice (ATJ), Legal Services Corporation, United Way, Interest on Lawyers Trust Accounts (IOLTA) and Victims of Crime Act (VOCA).

Funding specific to family law increased the number of family law clients KLS has been able to serve. Even with increased funding, the demand for direct representation in family law matters continues to exceed KLS' capacity. Priority is placed on cases of spousal or child abuse and protection from abuse orders.

PROGRAMS

SERVICES FOR SURVIVORS OF DOMESTIC VIOLENCE AND OTHER CRIMES

Every year, KLS provides assistance to thousands of survivors of domestic violence, sexual assault, stalking and other crimes. KLS uses funds from a number of resources, including Victims of Crime Act (VOCA), and Interest on Lawyers Trust Account (IOLTA) funding, to ensure that the legal needs of survivors and their families are addressed. In addition to needed legal assistance, KLS looks at the other needs of the survivors such as affordable, safe housing and income maintenance that will help them feel safe and stable.

Funders for this important work for survivors range from federal, state, county and local funds from across the state.



KIDS2KIN

The Kids2Kin program aims at reducing the number of children entering foster care, and preventing foster care placements for those at-risk by helping relatives or caregivers of the kids with guardianships and other legal issues.

KLS was the first legal service organization in the country awarded a grant from the federal Family First program in 2019.



PARENT ADVOCATE PROGRAM

The Kansas Department for Children and Families (DCF) contracts with KLS to provide case management and legal services to families in 10 counties. The mission of the Parent Advocate Program is to keep families together and prevent children from going into the foster care system. We do this through education, advocacy (personal and legal), and collaboration. Working with parents and caregivers, Parent Advocates provide resources, support, and guidance to strengthen families.

PROGRAMS

SUSPENDED DRIVER'S LICENSE REINSTATEMENT

Over 200,000 Kansans have a suspended or revoked driver's license, a mark which ranks as the 4th highest in the nation. These suspensions are the result of failing to pay a ticket, not showing up for a hearing, being in an uninsured wreck or not paying child support. The road to get a driver's license back is often hard to navigate.

In the fall, 2023, KLS was awarded a two-year special grant from LSC to partner with local bar associations, private attorneys and courts to conduct driver's license clinics around the state, staffed with volunteer attorneys.


EXPUNGEMENT

KLS conducts expungement clinics across the state through funding from the Kansas Bar Foundation, state funding, and in partnership with local bar associations. We rely on volunteer attorneys to help with these clinics.



WEBSITE



MARILYN HARP AWARD

2024 RECIPIENT: MATT ODOM

The Marilyn Harp Award honors the legacy of longtime KLS attorney and executive director Marilyn Harp. It is given annually to a Kansas Legal Services attorney in recognition of extraordinary service to clients.

This year's recipient, Matt Odom, has been the backbone of the KLS Hays office since his hiring on November 17, 2021. Until just recently, Matt was the only attorney in the office—handling an expansive range of cases across 21 counties, including family law, landlord/tenant disputes, elder law, debt defense, and guardianships. He is also the lead outreach attorney for the Area Agency on Aging (AAA) grant and oversees the Thomas and Ellis County Self-Help Centers.

Matt brings a rich background to KLS, including prior legal work in Colorado, his own practice in Hays, and service in the military. He is known not only for his strong legal knowledge but also for his deep compassion and calm professionalism.

From the beginning, Matt hit the ground running, sometimes even before his name was in the court system. In one early case, Matt took on a complex federal housing eviction case on behalf of a disabled veteran facing discrimination. Though new to appeals, Matt argued the case before the Kansas Court of Appeals and won a decision that will allow the eviction to be expunged—giving his client a second chance at stable housing.


One of Matt's first cases at KLS involved saving an 84-year-old blind woman in Norton, Kansas, from losing her home to foreclosure, a type of case he had never handled before. With little guidance, he taught himself the law, drafted the necessary documents, and personally visited the client, ultimately negotiating a successful settlement.

Matt does it all with humility, humor, and relentless commitment. Whether representing survivors of domestic violence, advocating for vulnerable seniors, or keeping the Hays office afloat single-handedly, Matt consistently delivers compassionate, high-quality legal help to those who need it most.

MIDLAND MEDIATION AND SETTLEMENT SERVICES: PROGRAM OVERVIEW

The KLS mediation program operates as Midland Mediation & Settlement Services. Midland utilizes mediators approved by the Kansas Office of Judicial Administration, who have met and exceeded the standards to serve as a state approved mediator. Our mediators have successfully facilitated thousands of cases and are highly trained, experienced, and educated in the field.

Kansas Legal Services, provides civil rights, employment, domestic, juvenile permanency, insurance and other mediation services throughout the state. Mediation services complement the work of KLS by providing a non-adversarial dispute resolution method for appropriate cases.

CITY OF WICHITA- NON DISCRIMINATION ORDINANCE

- * On October 12, 2021, the Wichita City Council voted to adopt a Non-Discrimination Ordinance (NDO), Ordinance 51-654, effective October 29, 2021. This ordinance is intended to assure equal opportunity for Wichitans and to ban discrimination or segregation in housing, employment and public accommodations based on age, color, disability, familial status, gender identity, genetic information, national origin or ancestry, race, religion, sex, sexual orientation, veteran status or other factor protected by law. KLS was awarded this contract and currently provides mediation services for the city of Wichita.

ACCESS TO JUSTICE (ATJ)

- * ATJ Mediations are funded by the Office of Judicial Administration under the direction of the Kansas Supreme Court. ATJ funding enables parties' access to KLS offices for mediation services at no cost to participants who qualify. Most ATJ mediations involve post-divorce custody and parenting time issues.

KANSAS HUMAN RIGHTS COMMISSION

- * Kansas Human Rights Commission offers voluntary mediation to individuals involved in employment, housing and public accommodation discrimination claims filed with the Kansas Human Rights Commission.

FOR-FEE MEDIATIONS

- * For-Fee Mediations are offered to parties in domestic matters on a sliding fee basis when neither party is ATJ-eligible, and is available to parties in some civil matters at a reasonable hourly rate, no more than \$75.00 with a \$15.00 administrative fee.

KANSAS BAR FOUNDATION EXPUNGEMENT PROJECT

- * Expungements help low-income Kansans compete for better jobs. The KLS Volunteer Lawyer Program partnered with local bar associations, corporations and private law firms to conduct expungement clinics in several locations. The clinics enhance the benevolent reputation of Kansas attorneys.
- * Expungement clinics were held in Wichita (in partnership with Koch), Johnson County (in partnership with T-Mobile), Ellis County, Wyandotte County and Montgomery County.



DRIVER'S LICENSE CLINICS

- * Suspended driver's licenses have become a hot-button topic over the past few years. KLS receives funding from the LSC PBIF grant to conduct clinics that provide assistance to people with persistent barriers to employment and housing, such as driving on a suspended or revoked license.
- * Clinics in 2024 were held in Shawnee County, Johnson County, Saline County and Douglas County using volunteer attorneys and law students.

KLS recruited over **100 private attorneys** to provide legal assistance to **629 clients** in 2024. These attorneys provided **725 hours** of legal services at no cost.



OUTREACH AND EVENTS




TRIVIA NIGHTS

CORPORATE SPOTLIGHT: T-MOBILE

Kansas Legal Services is proud to highlight one of several private–public partnerships with Kansas employers working to expand access to justice. One core example is our growing collaboration with T-Mobile, which has become a key partner in supporting second chances through expungement.

In both 2023 and 2024, T-Mobile hosted two expungement clinics in Johnson County, collaborating with KLS staff and volunteers to assist Kansans in clearing their criminal records of old or minor offenses that can create lasting barriers to employment, housing, and opportunities. These clinics are part of T-Mobile's broader commitment to community engagement and social impact in the regions where its employees live and work.

Through this partnership, T-Mobile provided both financial support and hands-on legal service, helping clients navigate the complex process of record expungement. The work T-Mobile and KLS have done together is a model for how employers can take an active role in ensuring access to justice. It reflects a growing recognition that removing legal barriers helps individuals realize their full potential and benefits entire communities.





WE ARE LEGAL AID AND THE EQUAL JUSTICE PROJECT

In 2024, Kansas Legal Services continued building an innovative partnership between the defense and plaintiff's bars, united by a common goal: to reduce domestic violence in Kansas by providing legal counsel to victims who would otherwise face the legal system alone.

This collaborative effort has already delivered meaningful results. Through the We Are Legal Aid campaign, 45 defense firms raised a total of \$55,250. At the same time, the plaintiff's bar supported the cause through the Equal Justice Project, with 10 firms raising an additional \$25,500. Together, these generous contributions are expanding access to legal services for some of the most vulnerable Kansans.

IN KANSAS, NEARLY 70% OF DOMESTIC VIOLENCE VICTIMS NAVIGATE THE LEGAL SYSTEM WITHOUT AN ATTORNEY.

Survivors of domestic violence and sexual assault face, on average, as many as 18 legal issues per person, including matters related to child custody, housing, health care, credit, education, and public benefits. Without legal representation, these challenges can feel insurmountable.

Thanks to this partnership, more survivors now have a voice in court, a path to safety, and the legal support necessary to rebuild their lives. This collaboration is changing outcomes and lives across Kansas.


